The regular meeting of the City Council was held on July 13, 2021 in the City Hall Council Chambers, 111 North Main Street at 7:05 p.m. Present: Mayor Zoppo-Sassu; Council Members Barney, Fortier, Hahn, Kelley, Preleski, and Rosado.

1. MOMENT OF REFLECTION FOR FAMILIES AND FIRST RESPONDERS INVOLVED WITH FLORIDA CONDOMINIUM BUILDING COLLAPSE.

Mayor Zoppo-Sassu requested a Moment of Reflection for the families and first responders involved with the Florida condominium building collapse.

2. APPROVAL OF MINUTES OF REGULAR CITY COUNCIL MEETING ON JUNE 8, 2021 AND SPECIAL CITY COUNCIL MEETING ON MAY 25, 2021.

On motion of Council Member Hahn and seconded, it was unanimously voted: To approve the minutes of the regular City Council meeting on June 8, 2021 and the special City Council meeting on May 25, 2021.

3. PUBLIC PARTICIPATION.

Donna Osuch, President and CPO United Way West Central Connecticut gave a presentation on the Farmers to Families program. She stated they distributed over 30,500 boxes of food. She presented a short video that explained the collaborative efforts of volunteers and the City of Bristol required to run the program.

7. MAYOR OR ACTING MAYOR AUTHORIZED TO SIGN DOCUMENTS FOR ENVIRONMENTAL CONSTRUCTION PERMITS AND STATE BRIDGE GRANT FUNDS TO REPLACE LAKE AVENUE CULVERT CROSSING CUSS GUTTER BROOK.

Communication from the Director of Public Works regarding permits and grant funds to replace the Lake Avenue Culvert crossing the Cuss Gutter Brook.

As part of the Consent Calendar adoption and on motion of Council Member Hahn and seconded, it was unanimously voted: To authorize the Mayor or Acting Mayor to sign any and all documents associated with obtaining environmental construction permits and State bridge grant funds to replace the Lake Avenue Culvert crossing the Cuss Gutter Brook. Said documents include but may not be limited to a Bristol Inland Wetlands, Connecticut DEEP and Army Corp of Engineers permit along with an application to the Connecticut Department of Transportation Local Bridge program.

8. MAYOR OR ACTING MAYOR AUTHORIZED TO EXECUTE AGREEMENT WITH OWNER OF LOT 17-118-11 SALVATORE AVENUE APPROVING USE OF PORTION OF SALVATORE AVENUE UNIMPROVED/UNACCEPTED RIGHT OF WAY FOR DRIVEWAY.

Communication from the Director of Public Works regarding use of a portion of Lot 17-118-11 Salvatore Avenue unimproved/unaccepted right of way for the purposes of a driveway.

As part of the Consent Calendar adoption and on motion of Council Member Hahn and seconded, it was unanimously voted: To authorize the Mayor or Acting Mayor to execute an agreement with the owner of Lot 17-118-11 Salvatore Avenue formalizing the Board of Public Works' March 9, 2021 action approving use of a portion of the Salvatore Avenue unimproved/unaccepted right of way for the purposes of driveway subject to filing documentation on the Bristol land records indicating the following:

1. Provide the City of Bristol an easement to store snow at the western terminus of the accepted City Street identified as Salvatore Avenue.
2. Portion of driveway located within Salvatore Avenue right of way shall be paved with bituminous asphalt.
3. File documentation on Bristol land records indicating approval with conditions including a statement that the existing Salvatore Avenue right of way located between Hull Street and Pleasantview Avenue is not and will not be classified as a City street. Access to lots are private driveways only. City services will not be provided within the referenced section of the right of way.

Communication from the Director of Public Works regarding environmental construction permits and LotCip grant funds to replace the Divinity Street Culvert.

As part of the Consent Calendar adoption and on motion of Council Member Hahn and seconded, it was unanimously voted: To authorize the Mayor or Acting Mayor to sign any and all documents associated with obtaining environmental construction permits and LotCip grant funds to replace the Divinity Street Culvert east of Peck Lane. Said documents will include, but may not be limited to a Bristol Inland Wetlands, Army Corp of Engineers and Connecticut DEEP permit along with an application to LotCip Grant program.

10. BOARD OF PUBLIC WORKS RECOMMENDATION TO APPROVE DEFERRAL OF SIDEWALKS ACROSS LOT 263-2 MINOR STREET, PLACED ON FILE.

Recommendation from the Board of Public Works regarding approval to defer construction of sidewalks across the property identified as Lot 263-2 Minor Street.

As part of the Consent Calendar adoption and on motion of Council Member Hahn and seconded, it was unanimously voted: To place on file the Board of Public Works recommendation to approve the deferral of construction of sidewalks across the property identified as Lot 263-2 Minor Street. Said approval is subject to filing a covenant on the Bristol land records stating "If sidewalks are constructed on the adjacent lots the City reserves the right to require the property owner to construct or pay for the cost of constructing sidewalks across the referenced property frontage 620 feet.

11. MAYOR OR ACTING MAYOR AUTHORIZED TO SIGN ENVIRONMENTAL PERMITS ASSOCIATED WITH RECONSTRUCTION OF WOLCOTT STREET, WOLCOTT ROAD, ROUTE 69 AT INTERSECTION OF ALLENTOWN ROAD, FALL MOUNTAIN ROAD, AND WITCHES ROCK ROAD.

The local match is 50/50 (\$40,000). It was also voted to refer this matter to the Board of Finance for any necessary action.

15. PUBLIC HEARING SCHEDULED FOR AUGUST 3, 2021 REGARDING PROPOSED AMENDMENTS TO BRISTOL CODE OF ORDINANCES SEC. 14-18, OPERATION OF BICYCLES ALONG PARADE ROUTES.

As recommended by the Ordinance Committee and on motion of Council Member Preleski, Chrm., and seconded, it was unanimously voted: To authorize a Public Hearing on Tuesday, August 3, 2021 at 5:20 p.m. in the First Floor Meeting Room, City Hall, 111 North Main Street, Bristol, Connecticut on proposed amendments to the Bristol Code of Ordinances Sec. 14-18, Operation of bicycles along parade routes and to waive the reading of the proposed amendments, but to include them as part of the minutes. The ordinance reads as follows:

Underscored text is proposed to be added. [Bracketed] text is proposed for deletion.

Sec. 14-18. Operation of bicycles along parade routes.

- (a) "Bicycle" means every device propelled by the feet acting upon pedals.
- (b) "Electric bicycle" means a bicycle equipped with operable foot pedals and an electric motor of fewer than seven hundred fifty watts of power that is either a class 1, class 2 or class 3 bicycle.

[(b)] (c) No person shall operate a bicycle or electric bicycle along any parade route unless authorized by the organizer of the parade. Members of the police department shall remove any bicycle or electric bicycle operated in violation of this section and provide for its custody at the owner's expense.

16. APPROVAL FOR CITY TO SEEK REQUESTS FOR PROPOSALS FOR PROFESSIONAL SERVICES RELATIVE TO SALE OF SURPLUS CITY-OWNED PROPERTIES.

Communication from the Purchasing Agent regarding requests for proposals for Professional Services Relative to the Sale of Surplus City-Owned Properties.

As recommended by the Real Estate Committee and on motion of Council Member Hahn, Chrm., and seconded, it was unanimously voted: That the City of Bristol seek requests for proposals for Professional Services Relative to the Sale of Surplus City-Owned Properties known as Request For Proposal 2P22-002. It was also voted to refer this matter to the Corporation Counsel to prepare and/or review any necessary documents and authorize the Mayor or Acting Mayor to execute any necessary documents to effectuate the same.

17. REFERRAL TO PLANNING COMMISSION FOR C.G.S. §8-24 REPORT FOR PURPOSE OF GIVING EASEMENT FOR HANDICAPPED RAMP AT 10 MAIN STREET, APPROVED.

Communication from the Assistant Corporation Counsel Steeg regarding a referral to the Planning Commission for the purpose of an easement for a handicapped ramp at 10 Main Street.

As recommended by the Real Estate Committee and on motion of Council Member Hahn, Chrm., and seconded, it was unanimously voted: To refer the following property to the Planning Commission for a C.G.S. §8-24 Report for the purpose of the City of Bristol giving an easement for a handicapped ramp on property known as 10 Main Street. It was also voted to refer this matter to the Corporation Counsel to prepare and/or review any necessary documents and authorize the Mayor or Acting Mayor to execute any necessary documents to effectuate the same.

18. MAYOR OR DESIGNEE AUTHORIZED TO NEGOTIATE AND ENTER INTO 90 DAY OPTION TO PURCHASE LAND SHOWN AS MAP 43 LOT 16 CHURCH STREET FOR NEW ENGINE COMPANY #3 FIREHOUSE.

Council Member Barney highlighted a need for a new firehouse because the space was confined and there were safety issues with motor vehicle accidents and cars going onto the property and toward the firehouse.

Mayor Zoppo-Sassu stated the firehouse had maintenance issues and was landlocked. There was another entity previously interested in this property, but the deal fell through. She noted money to purchase the parcel was included in last year's capital budget.

On motion of Council Member Fortier and seconded, it was unanimously voted: To bring on the table the purchase of vacant land for a new firehouse.

On motion of Council Member Barney and seconded, it was unanimously voted: To authorize the Mayor Ellen A. Zoppo-Sassu or her designee to negotiate and enter into a 90 day option at no cost to the City for the purchase of vacant land, 2.5 acres more or less, shown as Map 43 Lot 16 Church Street for a new firehouse for Engine Company #3.

19. MAYOR OR ACTING MAYOR OR OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT AUTHORIZED TO APPLY FOR CITIES OF SERVICE GRANT FOR \$100,000 OVER TWO YEARS.

On motion of Council Member Barney and seconded, it was unanimously voted: To bring on the table a Cities of Service grant for \$100,000.

Council Member Fortier stated eight cities would be selected for a grant to fight blight over two years and fund a Love Your Block Fellow, up to two AmeriCorps Vista members, and receive technical assistance from Cities of Service staff.

On motion of Council Member Fortier and seconded, it was unanimously voted: To authorize the Mayor or Acting Mayor or Office of Economic and Community Development to apply for a Cities of Service grant for \$100,000 over two years to support resident led efforts to fight blight and to fund a Love Your Block Fellow drawn from the community.

On motion of Council Member Barney and seconded, it was unanimously voted: To bring on the table a referral to the Zoning Commission.

Council Member Barney stated that local farm stands were excluded from the current zoning regulations. There was a complaint made against a local gardener for selling produce in a residential neighborhood. She noted these roadside stands provide equitable access to healthy food.

On motion of Council Member Barney and seconded, it was unanimously voted: To refer to the Zoning Commission to review and include language to allow the on-site sale of produce or agricultural products in the zoning regulations.

21. APPROVAL TO SUBMIT NATIONAL RECREATION AND PARKS ASSOCIATION YOUTH SPORTS AND PLAY GRANT 2021 TO INSTALL NEW LIGHTS FOR BRACKETT PARK BASKETBALL COURTS AND MAYOR, ACTING MAYOR, OR SUPERINTENDENT TO APPLY.

On motion of Council Member Rosado and seconded, it was unanimously voted: To bring on the table a National Recreation and Parks Association Youth Sports and Play Grant.

On motion of Council Member Rosado and seconded, it was unanimously voted: To approve submission of a National Recreation and Parks Association Youth Sports and Play Grant 2021 for a maximum grant award of \$40,000 to support installation of new lights for the Brackett Park Basketball courts, to authorize the Mayor, Acting Mayor, or Superintendent of Parks, Recreation, Youth and Community Services to execute any and all documents necessary to submit the grant/ application, and to refer to the Board of Finance for appropriation.
