It is necessary to deposit advance funds to obtain printing access. Monitor your balance often, so you won't experience a delay in printing pages. Your balance can be viewed at the top right corner of the login screen. Payment may be made to our office in the form of cash or a check payable to: "Bristol Town Clerk".

NOTES FOR ON-LINE IMAGING

1 . ONE LOGIN – Although the login information can be shared within a company or firm, only one person can be logged in at a time. If someone tries logging in while another person from the same company is already on-line, the person currently logged in will be kicked off. Should you need it, multiple logins for one firm can be purchased at a reduced rate. Inquire for more information.

2 . ACCESSING IMAGES - To access an image, click on the pages to the right hand side of the screen under “Images”. The document image will be displayed.

3 . PRINT - To print one page at a time, simply left click once on the thumb tab containing the page on the left hand side, right click, choose “print” and print page. You can also print the entire document by using the “Print All Pages” button at the top of the search page.

1905 – 1974 ONLINE INDEX

The land record indexes for 1905 – 1974 are on-line as well. You can find the tab for these indexes at the top of the e-search screen. With these indexes you must enter the name you are searching, whether they are a grantee or a grantor, an individual, or a corporation/firm. If you wish to print a page the print button is located at the top of the e-search results page. Should you need a copy of an image from 1905 – 1974 that has not been scanned, simply call or e-mail us and we will e-mail the copy. This service is for subscribers only.

The following are helpful hints when searching the indices:

Mary St. James indexed as MARY SAINTJAMES (without a space).

Jim De Vino indexed as JIM DEVINO.

Numbers are indexed numerically and alphabetically (12 and Twelve).

Milo Builders Inc. is indexed as A MILO BUILDERS INC (no periods).

City of Bristol indexed as BRISTOL CITY OF.

State of Connecticut indexed as CONN STATE OF.

Connecticut Housing Finance Authority indexed as CONN HOUSING FINANCE AUTHORITY

HUD is indexed as HOUSING & URBAN DEV SEC OF and UNITED STATES OF AMERICA HOUSING & URBAN DEV.

Streets can be searched under HWY after 1975, HIGHWAY (Corporation) prior to 1975.

*Probate Certificates (PC-255) recorded in the 1970's were indexed with the estate name in the Grantee index.

*From 1975 – 2005, when BRISTOL CITY OF was the Grantee on a water, sewer or tax lien, it was indexed as - BRISTOL CITY OF (with hyphen before the word BRISTOL).

ON-LINE IMAGE ACCESS FOR THE CITY OF BRISTOL LAND RECORDS

The Bristol land record indexes are available on-line from January 1, 1882 to current day and up-to-the-minute. For a fee of either \$130 for 1 year, \$30 for 30 days, or \$100 for an annual renewal, you may access the on-line land record images from March 22, 1787 Volume 1 to the present and all the trade name images. The land record documents and maps that are available in the indexes, but not yet scanned, can be electronically transmitted to subscribers. Contact us about this subscription service at (860) 584-6200 ext. 0.

If you choose not to utilize our new service, only the indexes are available on-line. You would need to visit the Town Clerk's Office to obtain copies of the documents.
